# Accessibility statement

DiliTrust is committed to ensuring digital accessibility for people with disabilities.

This accessibility statement applies to DiliTrust iOS version 3.1.

## COMPLIANCE STATUS

The DiliTrust iOS application version 3.1 is partially compliant with WCAG 2.2 Level Double-A (AA) due to the non-compliances and exemptions listed below.

## TEST RESULTS

The compliance audit carried out by ipedis reveals that **50% of the WCAG 2.2 criteria are met.**

## NON-ACCESSIBLE CONTENT

The content listed below is not accessible for the following reasons.

- **Information and relationships**  
Certain semantic relationships are not correctly conveyed to assistive technologies, making it difficult for VoiceOver users to understand the content.
- **Logical sequential order**  
The navigation order is not always coherent, which can disrupt the experience for users navigating with VoiceOver or an external keyboard.
- **Sensory characteristics**  
Some instructions rely solely on visual characteristics (shape, color, position) without alternatives for users with sensory impairments.
- **Orientation**  
The application does not always adapt properly when switching from portrait to landscape mode, making certain content inaccessible.
- **Use of color**  
Some information is conveyed solely through color, without textual alternatives or additional indicators, which can be problematic for colorblind or visually impaired users.

- **Contrast (minimum)**  
Some text does not provide sufficient contrast with its background, making reading difficult for people with low vision.
- **Contrast of non-text elements**  
Icons, buttons, and other interactive elements have insufficient contrast, reducing their visibility and usability.
- **Text resizing**  
The application does not support the iOS “Larger Text” option, making certain texts unreadable when users increase the font size.
- **No keyboard trap**  
Some interactive elements do not allow for an easy return, potentially trapping users navigating with a keyboard or VoiceOver.
- **Focus order**  
Focus is not always clearly visible or logically restored, complicating navigation for VoiceOver users.
- **Labels or instructions**  
Some input fields lack accessible labels or clear instructions, making them harder to understand for screen reader users.
- **Error suggestion**  
When an error occurs in a form or input field, no suggestion is provided to help the user correct it.
- **Name, role, value**  
Certain interactive elements (buttons, links, controls) lack accessible names, preventing VoiceOver from announcing them correctly.
- **Status messages**  
Status messages (confirmation, error, loading) are not properly conveyed to assistive technologies, leaving users without feedback on their actions.
